## AIA 2030 Design Data Exchange FAQs

### Is the AIA 2030 DDx operational?

## **Are there plans for professional educational / engagement sessions at AIA Convention 2015?**

AIA will be scheduling online training in the coming weeks.

## **What are the planned upgrades for the next phase?**

The AIA is committed to continually enhancing the AIA 2030 DDx platform. We have a list of upgrades and enhancements that we are currently reviewing and vetting with the 2030 working group to determine our most urgent priorities, such as importing data from energy modeling software and adding climate zones to research filters. ## **Is there a schedule for these upgrades?**

As with any software tool, new versions will be released on a regular schedule to ensure bug fixes are addressed as soon as possible. The first upgrade of the AIA 2030 DDx, which will add new features and capabilities, is expected in late 2015/early 2016.

## **When will the 2014 data be imported into the AIA 2030 DDx?**

You can expect to see the 2014 reporting data in the AIA 2030 DDx system by early July.

## **Will my firm, project and client information be private?**

Yes, confidentiality is a primary tenet of the 2030 Commitment program. Once projects are added to the AIA 2030 DDx, users will not be able to view individual projects by firm, project type, or zip code. Projects can be sorted by filters, including building type and location in the Research feature of the portal; however if the dataset returns fewer than 10 projects in the search results, no projects will appear. This limitation was designed to protect the anonymity of unique projects.
