Our profession is beset by threats and challenges, from the stubborn decline in billings to the impending talent gap and AI encroachment that will make practice even harder. As problem solvers, we naturally want to try to solve them all. However, if we want to grow our influence with policymakers and the broader public we need to insert ourselves into issues that affect the lives of our fellow citizens.

One success story is climate action, an urgent matter the AIA has pledged significant resources to. AIA members and leadership are speaking with one voice at all levels and leading the conversation. There is, however, an issue just as critical, where I have seen us sidelined in the national conversation and largely cut out from local working groups: the housing crisis. Despite the clear intersection between housing and our profession, we are not regularly at the table and not doing enough to be there. This is an area where the AIA can lead at the local, state, and national level on an issue that affects everyone. My expertise and knowledge can be the driving force behind it.

Just as with climate action, the need has never been greater to solve this pressing issue. As architects, we have the creativity, know-how, and problem-solving skills to lead the country out of this. In my almost 20 years of practice, I have been deeply involved in this issue in the triumvirate of practice, policy and publication. That includes designing over 1500 units of affordable housing, establishing the AIA Pennsylvania Statewide housing committee and dedicating magazine volumes to it. I also develop housing at all income levels and have brought a mix of 500 units online in the past 4 years. Through the latter, I have worked with land banks, municipalities, and policymakers to give them ideas and have successfully worked through projects that make sense for all stakeholders. I know this issue. Pivoting to a new topic takes dedication and I am in the position to do just that.

Once we re-establish ourselves as an authority on a pressing issue like housing, we can go back to solving other problems. For now, my vision is to stay focused, prove that the AIA should have a permanent seat at this table, and show how our ideas will lead to success. Put me in coach.

Lisa L. Kennedy, FAIA, attended the University of Wisconsin-Milwaukee and received a Bachelor of Science in Architectural Studies in 1981 and a Master of Architecture in 1984. While in school, she served as local chapter president of the Association of Student Chapters/American Institute of Architects, (ASC/AIA, now AIAS) and as the North Central States Regional Director and as a Director at Large on the ASC/AIA National Board of Directors. She also created and held two ex-officio positions on the Wisconsin Society of Architects Board of Directors: Student Representative in 1983, and Associate Representative in 1985.

Outside of architecture school at the university, Ms. Kennedy was the manager of the student government office, served as Secretary of the Student Senate, and was appointed to the Chancellor's Campus Environment Committee.

Ms. Kennedy became a registered architect in 1987 and worked for several small Milwaukee-area architectural firms whose focus ranged from traditional practice to design/build, and for the Milwaukee Redevelopment Corporation, a private, non-profit civic development group. Ms. Kennedy started her own practice in 1987, offering architectural and interior design services, and operated it until 1999 when she transitioned to Vice President of Design and Construction for Manna, Inc., one of her former clients. The company, founded by former NBA player Junior Bridgeman, owns and operates over 500 restaurants nationally. After retiring from practice in 2020, she was selected as the Executive Director of AIA Wisconsin through a nationwide search.

Ms. Kennedy served as President of the Wisconsin Society of Architects (now AIA Wisconsin) in 1994 and was the youngest person and first woman to serve in that capacity. She was elected as the AIA North Central States Regional Director in 2001 and served on the national Government Affairs and Membership Committees, as well as the chair of the Institute Honors for Collaborative Achievement Awards jury during her tenure, which ended in December of 2003. She also served as chair of the 2004 AIA National Convention, which was held in Chicago. In 2014 she was elected to the Wisconsin Architects Foundation Board of Directors for a three-year term. She was elevated to Fellowship in the American Institute of Architects in 2017 and served as a Regional Representative for the national College of Fellows. In her role as Executive Director, she served on the Council of Architectural Component Executives (CACE) Executive Committee from 2022-23 and remains on the AIA's national Government Advocacy Committee.

In 1990, she received an Outstanding Young Alumni Award from the University of Wisconsin-Milwaukee. She became an adjunct faculty member at the university in 1996 and was appointed by former Wisconsin Governor Tommy Thompson to serve on the Examining Board of the Department of Regulation and Licensing from 1996 – 1999. In 1997, she was appointed to a subcommittee of the National Council of Architectural Registration

Boards, to write and pre-test questions for the Graphics Division of the Architectural Registration Exam.

In 2005, Ms. Kennedy was selected to receive AIA Wisconsin's Golden Award, which the highest honor that the society confers upon a member. The award recognizes "her significant contributions to the American Institute of Architects at the local, state and national levels, her distinguished service to the profession of architects on licensing and other government affairs issues and the inspiration she has provided other architects to get involved and make a difference in shaping their profession and their communities."

In 2009, Ms. Kennedy was awarded the Donna Schuloff Award, which is an annual award recognizing outstanding service and leadership.

Ms. Kennedy has been involved in a number of Milwaukee civic organizations as well. She served on the community of Whitefish Bay Board of Appeals from 2000-2004. She served on the Board of Directors of both the Wisconsin Women's Business Initiative Corporation, an organization that provides training and capital to disadvantaged and startup businesses, and Professional Dimensions, a professional women's group. She has served on committees for the Milwaukee Foundation's Women's Fund, a charitable foundation, and for the Girl Scouts of the Milwaukee Area. In 1997, Ms. Kennedy was awarded the Outstanding Woman of Achievement Award by the YWCA of Greater Milwaukee and was honored by the Business Journal of Milwaukee as one of the "40 Under 40" area business leaders.

Ms. Kennedy is mom to her two adult daughters, Erin and Stefanie. She performed her tour of duty as soccer team manager, Girl Scout leader, chauffeur, and supportive fan. "We must show enterprise to advance society and drive prosperity for those we serve."

I practice architecture in the Midwest and my clients are pragmatic about what they want. They want more square footage, more space for collaboration, and more parking. But—and this might sound familiar to you—it is my job to understand what they need, and what they need are environments that sustain us and help us thrive.

Note that I just stated that I practice architecture, rather than "I am an architect". It's intentional, because there are so many ways to identify as an architect in today's world. Architects do so many things. Some run a business and teach as I do, others provide C-suite strategies, others engage communities, and still others work with agencies to set policies that will endure. You might say that there are a lot of ways to pronounce the word "architect". You might also be compelled to re-think, re-design, and re-envision our profession itself. But, for me, it starts by remembering that architecture is a practice in the first place. And to practice is to strive, to practice is to adapt, to practice is to listen and learn, and to practice is to design and align ourselves with the people whose lives are improved, measurably and immeasurably, because of our compassion and talent. The truth is that 99% of the work we do, no matter where we are, is for people we'll never meet.

We will never know the thousands of people whose lives will be shaped by our work in 10, 20, or even 50 years.

Yet, those people are our clients, too. We will never know their challenges or struggles or delight in the homes or workplaces or schools we design today. Those people are the reason I say I practice architecture. Because it's not about me being an architect. It's about being in a perpetual state of answering the greatest need of our clients today, which is to design a brighter, healthier, more adaptable, more equitable future, which is not only possible, but imperative.

My first job was for a talented, charismatic architect in Chicago who told me that the way to improve lives was to make beautiful places. I believe that's true. But I also believe that beauty is not always about place, and it's not always about aesthetics, either. It's about empowerment. I've seen what happens when architects are empowered to recognize the opportunity to do extraordinary work when it appears, and to go out and get that work when it doesn't appear, when they are empowered to expand the partnerships of our industry however broadly you define it, when they are empowered to be the focused and unified voice for the designed environment, when they are empowered to expand research, exchange ideas, and establish a multi-disciplinary knowledge base, when they are empowered to advocate for design's capabilities on the Hill, in state legislatures and in

cities and towns, and, above all, when they are empowered to foster and cultivate emergent, diverse, and varied voices.

I want us to Do Better Together.

Doing better together starts with doing something to improve the world we've found and the world we're making for future generations. Doing better together starts with doing something...because architecture is a practice in the first place.

Doing better together means encouraging contributions from everyone because the environments we create should be for anyone to enjoy, including the clients we know and the ones we'll never know who may occupy our buildings in 10, 20, or 50 years. Doing better together means never stopping because architecture is a perpetual practice that unifies all of us and the 100,000 members of the AIA.

I am asking for your vote, because I do not believe architecture is just about forging an identity but about having the courage to solve problems that we are uniquely able to solve.
