She has fostered a thriving community of immigrant architects within the AIA through events, public speaking, and her leadership in a podcast that highlights immigrant journeys. Her dedication to uplifting underrepresented voices within the profession is unparalleled.

Graciela's resourcefulness was particularly evident during the COVID-19 pandemic. As President of the AIA Long Island Chapter, I personally witnessed how she kept the chapter vibrant and engaged at a time when most programs had ceased. Her leadership was instrumental in revitalizing the chapter, and under her guidance, the AIA Long Island Board increased female representation to 50%, a significant growth from 10% in 2011, when Graciela first joined.

1.0 Summary

Graciela Carrillo tenaciously created paths for women, immigrant architects and emerging professionals, thereby expanding and strengthening the AIA community. Her initiatives extend globally, empowering immigrant architects and elevating Latina representation in the profession.

Strengthening and Expanding the AIA Community

Graciela leads AIA's equity imperative through her leadership of the AIA Strategic Council equity study group, where she created a framework for achieving a bias-free profession by 2050.

Utilizing the Council's state representative structure, she engaged AIA components both nationwide and internationally to promote the equity goals of the 2021-**2025 AIA Strategic Plan** (Exhibit 3.1). As the 2024 Moderator of the Council, she established the Council's communication plan for dialogue with AIA member groups, states, components, and the public, and shared the Council's work with through publications, surveys and social media. Graciela implemented a new structure for the Council study groups that included liaisons from the Young Architects Forum, the National Associates Committee, and the AIAS, ensuring the younger generation of architect has a direct voice in shaping the profession's future. This inclusive collaboration of young professionals was the first initiative of its kind at the Council (Exhibit 3.2). As a result of her work with the Council, Graciela was elected to serve as the 2025-2027 Director at Large on the AIA National Board.

As the first Latina President of AIA Long Island, Graciela used her visibility to expand member engagement During the pandemic shutdown, she launched online communication resources to keep members connected (Exhibit 3.7). **Graciela founded the AIA LI Women in Architecture (WiA) committee, which led to an increase in female board leadership from 10% in 2018 to 50% in 2024,** and created the AIA LI scholarship for female architecture students in Long Island, providing funding for eight students so far. Graciela also established the AIA LI Emerging Professionals committee, which developed a mentorship program for students, associates, and young professionals. (Exhibit 3.8).

As the New York Young Architects Forum Regional Director Graciela created programming for emerging professionals through the New York State Emerging Professionals Forum and created the AIA New York State Young Architect Award which gave statewide visibility to the significant contributions of young architects (Exhibit 3.6).

Making Meaningful Connections Across Borders

To support the immigrant architect experience within the US, Graciela established the Immigrant Architects Coalition (IAC), a national nonprofit that provides support and resources for professionals coming to the U.S. In 2022, she coauthored and published the book City Shapers: Stories of Immigrant Designers, which was a best seller on Amazon and sold out at the AIA A'23 conference in San Francisco. In 2024, she coauthored with IAC to and published Prospering in the US, A Handbook for Immigrant Architects, another bestseller that also sold out at AIA A'24 conference in Washington D.C. (Exhibit 3.4)

Graciela also launched the IAC podcast for immigrant architects to share their stories. It has been downloaded over 1,000 times in 40 countries and six continents.

She collaborated with IAC fellow members to create a scholarship for international students on J1 and F1 visas enrolled in U.S. architecture schools. The first year the program received 46 applications from across the country. In 2024, Graciela launched an IAC mentoring program designed to pair licensed immigrant architects with immigrant professionals who are pursuing licensure. (Exhibit 3.4).

An impassioned advocate for AlA's global impact, Graciela collaborated with fellow members of the AlA Global Practice Committee (GPC) to establish the 2023 edition of the Global Practice Primer to adapt it to current conditions after COVID times (created originally in 2017). To expand the committee's reach, she created a handbook to guide other components to open their own Global Practice Committee resulting in new committees at local AlA components. Leveraging on her network of immigrant architects, Graciela has lead AlA's efforts to advocate for architecture to be listed as an eligible category in the O-1 Extraordinary Ability visa, to allow for increased participation by international architects and ultimately boost and diversify AlA membership (Exhibit 3.3).

Elevating Visibility of Diverse Professionals

To elevate the visibility of Latina architects, who represent only 1.7 percent of licensed architects in the U.S., Graciela works with Arquitina, a national nonprofit organization focused on increasing licensed Latina representation in the profession. **Through this network, she has worked with over 100 Latinas seeking licensure or to advance their careers.** Graciela's story of professional leadership was included in the award-winning book *Latinas in Architecture*. Graciela is working on programs dedicated to mentoring and guiding Latinas to pursue and earn professional recognition and elevate their profiles as leaders in the profession (Exhibit 3.5).

Through her role as senior project manager for the Nassau Board of Cooperative Education Services (BOCES), she empowers administrators to tackle pressing challenges facing public school facilities. She leveraged her role as an AIA leader in the Long Island region to create a webinar series in collaboration with Nassau BOCES highlighting K-12 facilities case studies that addresses complex issues, including the effects of the COVID-19 pandemic on school use and how school designs could be more adaptable. She brought speakers from five countries to lead the webinars, with more than 400 people from around the globe attending. She also led the implementation of staff development programs and continuing education programs on education facilities management to address challenges while promoting diversity, sustainability and global collaboration among students and faculty. Working with the National Association of Women in Construction, she helped plan and jury the Block Kids Building Program, which introduces K-6th grade students in Long Island schools to the construction professions (Exhibit 3.9).

As a high-profile Latina architect and advocate, Graciela sets a powerful example in the community and in the profession.



Challenge & Response

Equity was identified as an imperative in the AIA Strategic Plan and a profession-wide initiative was needed to identify a unifying objective for advancing equity. As the AIA New York State representative on the Council Graciela chaired the Council's Equity Study Group in 2022 and cochaired it in 2023, where she developed a framework aimed to achieve a bias-free profession by 2050.

Role & Outcome

- Championed AIA's equity imperative by developing a framework achieving a bias-free profession by 2050. Leveraging the Council's network of state representatives, she involved AIA components across the country and abroad to advance the equity objectives outlined in the 2021-2025 AIA Strategic Plan.
- As co-chair, created and shared the Council's research into bias in architecture consisting of compiling data to identify how bias was differentiated across regions nationally and internationally. The study group compiled over 100 surveys and findings were shared at a national virtual Council meeting and the broad membership.

- Identified gaps in AIA members' awareness and usage of key resources, specifically the Equity and the Future of Architecture Committee (EQFA), Women's Leadership Summit (WLS), Guides for Equitable Practice, and studies like "The Elephant in the (Well-Designed) Room: An Investigation into Bias in the Architecture Profession". Many national programs, including Next to Lead and Women's Leadership Edge, remain underutilized, with many AIA components lacking EDI committees to address these issues. Through a survey of the Strategic Council, Graciela found that: 41% were unfamiliar with the AIA Equity and the Future of Architecture Committee (EQFA), 30% had not read or skimmed the study "The Elephant in the (Well-Designed) Room", and 18% were unfamiliar with the AIA Women's Leadership Summit.
- Advanced and promoted the work done by AIA Minnesota titled "Culture Change in Architecture". Graciela invited Mary-Margaret Zindren, CAE, to present the study to the Strategic Council, improving the understanding of the role that AIA members have as ambassadors of EDI, and the goal was to be successful at building AIA collective knowledge, building the capacity and competence to talk about equity and to be able to center equity at the work architects do as professionals and as leaders. This presentation was scripted and made available to all Councilors, so they present it at their State Components.
- Streamlined AIA's equity initiatives intersecting the study "A Bias Free Architecture in 2050", by inviting EQFA leaders and Equity, Diversity, and Inclusion (EDI) Strategies staff to identify initiatives and goals regarding EDI programs.
- Organized a roundtable discussion at the AIA A'23 conference, which collected data and information from other members. Roundtable discussions delved into bias behaviors, obstacles, and policy reforms across five key areas: access to the profession, licensure, workplace culture, professional development, and the business of architecture.





Challenge & Response

The AIA Strategic Council is responsible for informing the Board of Directors and other AIA bodies of challenges facing the profession and strategies for how AIA can fulfill its mission in the future. Although the council plays an important role in the profession, not many AIA members know of the Council or its work.

As 2024 Moderator of the Council, Graciela introduced new initiatives that significantly improved the Council's operations, communications, visibility, and sense of fellowship.

Role & Outcome

- Established the Strategic Council's 2024 agenda and operating plan resulting in research projects in the areas of Climate and Water, Equity, Al, Value of Architecture and Health and Wellbeing and recommendation to the AIA Board for advancement.
- Created a format for the Council to sponsor Resolutions at the AIA
 Annual Meeting, including engagement of current and past Councilors, resulting in passage of the Council's first ever Resolution focused on advancement of human health and wellbeing.

- Created a Town Hall format for sharing the role of the council with AIA state and component leaders, piloted with the AIA Ohio Town Hall with the Ohio Council representative, to lead a discussion to inform the state leadership about the Council's role, goals, and areas of study. She shared this format with the Council to allow other states and components to replicate this communication strategy.







The concept of working abroad remains largely unexplored by many U.S. architects, particularly for newer and small firms. Meanwhile, members of AIA chapters abroad frequently experience a sense of disconnect from their American peers. Graciela shares her own experiences working in South America the first-hand knowledge drawn from her immigrant architects' network and other international practitioners to encourage local architects to step into the global design field.

Role & Outcome

- Because AIA has determined that addressing immigration status
 is crucial for integrating globally practicing architects into the U.S.
 profession, including architecture as an eligible category for the O-1
 Visa that would draw international architects, potentially boosting
 AIA membership while enhancing the organization's diversity and
 expertise. Graciela used her immigrant architects' network to refer
 successful O-1 applications to the AIA Governance staff team and
 assist in the process to advocate for this inclusion into the visa
 requirements.

The Immigrant Architects Coalition Podcast invites speakers to share their immigrant architectural path and helps create a community of support for those advancing in their careers as immigrant architects

- appointed its Board of Directors, appointing Graciela as Vice-President and Treasurer. This was a crucial step in shaping the direction and leadership of IAC and laying the foundation for its mission and initiatives
- Graciela, through the IAC, has furthered her impact through contributions to numerous articles and interviews for various organizations. This year the IAC published "Prospering in the U.S.: A Handbook for Immigrant Architects," a comprehensive resource guide featuring insights from over 20 design professionals across the country. This book is a valuable tool for navigating the unique challenges of the architectural profession. Another noteworthy achievement is the 2022 launch of "City Shapers: Stories of Immigrant Designers". This initiative has not only significantly contributed to communities across the United States but has also become a source of inspiration within the profession, fostering a dynamic platform for shared experiences and community building. (See Exhibit 3.10).
- The Immigrant Architects Coalition Podcast was also launched in 2023 with Graciela as one of the hosts. The podcast offers a dynamic platform for immigrant architects to share their stories, insights, and expertise. Its release marked a significant milestone, providing a valuable resource for both aspiring and established immigrant architects and anyone interested in the intersection of architectural and cultural diversity. Today, the podcast has been downloaded 1,341 times, listened to in 376 cities, 44 countries, and six continents.
- The IAC scholarship program was launched in 2024. IAC has expanded its mission to include support for international students with F-1 or J-1 visas and emerging professionals preparing for their ARE exams. The organization has recently inaugurated its first year of the IAC Scholarship, providing financial assistance for eligible individuals in 2024. Graciela and the IAC Board evaluated 46 applications from international students to award funds to one candidate. The ARE Scholarship will be launched in Winter of 2025.

Challenge & Response

Arquitina is a non-profit organization founded by Alicia Ponce, AIA to increase the number of licensed Latina architects in the U.S. While women represent close to 50 percent of architectural degree recipient and earn licensing requirements 1.2 times faster than men, they only represent 17 percent of firm principals and/or partners. In addition, women of color experience a lack representation both in academia and professional practice due to disparity in wages, promotions, and recognition, which affects their career trajectory. A 2020 NCARB report shows that non-white candidates are 31 percent more likely to fall off the path of licensure. Graciela works with Arquitina to mentor and advocate for LatinX Architects.

Role & Outcome

- Graciela joined Arquitina as co-author of the book "Latinas In Architecture". The book features the stories of 19 Latina Architects. In 2022, the book was awarded Best Latina Themed Book at the 2022 International Latino Book awards.
- In 2022, Graciela joined the Mentoring Planning Committee, which pairs Latina mentees with registered Latina architect mentors twice a year. She leads the process of organizing lectures provided for each ARE exam section for each cohort.

- In 2021 and 2022, Graciela created brought other Latina's peers to speak at the AIA Long Island Chapter and later on at the AIA New York Chapter to provide visibility to the Latinas in the NY metro area.
- Since 2022, Graciela has personally mentored 15 Latinas seeking licensure or seeking to advance their careers. The cohorts have provided mentoring to more than 100 Latinas. Since the creating of the mentoring cohorts, 12 Latinas have become licensed architects in the U.S.
- In 2024, Graciela led the LatinX advocacy group, a coalition of Arquitina, Arquitectos, La Idea, AIA Latinos in Architecture, and the Association of Dominican Architects in New York (ADANY) to advocate for a more diverse profession and provide support and resources to Latin architects or aspiring architects.

As the 2017-2018 New York Young Architects Regional Director (YARD), Graciela focused on engaging and promoting communication and connection between young architects and the AIA, and bridging the gap between emerging architects and the established community. One of her key initiatives was providing a platform to showcase young professionals who were established leaders within their region to allow their achievements and contributions to inspire and motivate other young architects to get involved and understand their potential impact.

These programs addressed young architects' unique challenges and opportunities, providing them with valuable resources, networking opportunities, and professional development. Moreover, Graciela implemented a new governance body for the New York State Emerging Professionals Committee. The new structure ensured that young architects' voices were heard and that their needs and concerns were addressed at a higher level. This governance body provided a formal mechanism for emerging professionals to contribute to the decision-making processes and initiatives of AIA NY State.



Challenge & Response

Graciela arrived to Long Island in 2003 and began her professional journey as an intern architect on an H-1B visa. With no local contacts in a new country, she joined the AIA to network with architects and pursue her licensing. She started as the associate director of the AIA Long Island Chapter. After obtaining her license, Graciela advanced through various board positions, eventually becoming the first Latina and only the third woman to serve as AIA Long Island Chapter President in 2020. When Graciela joined the board, she decisively revamped the AIA LI design awards program which resulted in a 65% improvement in submissions. important chapter programs like the Archi Design Awards program needed to be revamped. Her presidency, marked by the challenges of the COVID-19 pandemic, rose to new heights of member engagement online.

Role & Outcome

In 2017, Graciela changed the format of the LI Archi Design Awards program, from paper to an online submission and evaluation by jurors. Submissions to the LI Archi Design program increased 65% because of the redesign. In addition, Graciela revamped the awards presentation format, redesigned the LI Archis journal, the publication

- of the chapter's LI Archi Design Awards, anf is now a magazine professionally produced in Los Angeles by Yu-Ngok Lo, FAIA.
- Graciela created social media visibility for the AIA LI Chapter by establishing and managing Facebook and Instagram accounts. In six years, the social media pages have reached over 2,500 followers. This visibility expanded the knowledge of architecture to non-architects and the community in general. She also redesigned the chapter's website herself as a cost-saving measure for the chapter.
- In 2015, Graciela co-founded AIA LI Emerging Professionals as a support group for associates and young architects. She served as cochair from 2015 to 2019 and continues to serve an advisory capacity (see also Exhibit 3.2).
- In 2018, Graciela created the Women in Architecture Committee, which she still chairs, creating programs for women to advance in their careers and leadership skills (see also Exhibit 3.3).
- During her tenure as president in 2020, Graciela organized and facilitated a panel discussion with Long Island firm owners titled "LI Architectural Firms Working Remotely and Restart." It was the first online webinar hosted by the chapter. The conversation addressed best practices for remote working and leveraging online resources to maintain production and communication. She launched more online meetings to keep the membership engaged, including happy hours, panel discussions, and expert speakers.
- As AIA LI President, Graciela collaborated with USGBC Long Island Chapter to develop joint member sessions regarding sustainability on Long Island and teamed up with the American Society of Landscape Architects NY Chapter to develop a session with speakers from Colombia, Mexico and the US.
- In 2021, under Graciela's tenure as President, the AIA LI Chapter was awarded the AIAS Outstanding AIA Component Award for exemplary engagement with local AIAS Chapter and student leaders, outstanding contributions to professional development and career counseling of students.

Challenge & Response

Graciela joined the AIA Long Island Board in 2012 as Associate Director, noticing the low participation of young professionals despite a significant number of Associate members. In response, she founded the chapter's first AIA Long Island Emerging Professionals Committee (AIA LI EP) in 2015 to engage young architects, helping them develop skills and contribute to the organization. In 2017, after receiving the Sho-Ping Chin Leadership Scholarship and attending the AIA Women's Leadership Summit, Graciela was inspired create a greater support and representation of women in architecture within her local chapter. In 2018, she co-founded the AIA Long Island Women in Architecture Committee (AIA LI WIA). As co-chair, she has been instrumental in promoting the success and leadership of women in the architectural industry by fostering fellowship, cooperation, and networking opportunities.

Role & Outcome

AIA Long Island Women In Architecture Committee:

 Thanks to Graciela's efforts and the collective work of the AIA LI WIA committee, the board's female participation increased from 10 percent in 2018 to 50 percent in 2024.

PARTY OF THE PARTY

The AIA Long Island Chapter's Women in Architecture Committee has grown into a vibrant community, fostering fellowship and cultivating leadership within the Board of Directors.



The AIA Long Island Emerging Professionals committee has maintained its mission to support aspiring architects to obtain their license. Throughout the year the Committee hosts ARE Study sessions and invites speakers for each of the exams.

- In 2022 she led efforts to establish the WIA Inspire and Aspire
 Scholarship, which has since given more than \$10,000 to final-year
 female architecture students who reside in Long Island or are attending
 a Long Island-based architectural program.
- To create the WIA committee, Graciela personally recruited the co-chair and four other members. Today, the committee has 16 active members and membership increases each year.
- In 2021, she initiated speed mentoring with nine mentors from AIA Brooklyn and AIA LI joining online.
- In 2020, Graciela realized that six of the 13 NYS chapters, were led by women, including Long Island. To highlight their work related to the challenges brought on by COVID, she organized and brought them to join a webinar panel discussion titled "Strong Leaders in Tumultuous Times".
- In 2021, to bring recognition to the AIA NY Civic Leadership program, Graciela brought past and current program members to speak and provide awareness on how to engage women in civic leadership roles and how to maximize their potential.
- In light of the Black Lives Matter movement in 2020, Graciela brought prominent women activists and advocates to participate in a panel discussion, "Voices of Equity, Diversity, Inclusion: Championing Change." Panelists were Pascale Sablan FAIA, Bollanle Williams-Olley, Danei Cesario, and Julia Gamolina.
- In early 2020, Graciela organized a panel discussion with leaders from the National Women in Construction Association New York Chapter titled "Women Reshaping the Construction Industry." This event was the start of an ongoing collaboration between the two organizations that includes juries for student competitions and Girl Scouts Lego competitions.

- In 2022, only 17 percent of all registered architects were women and the
 percentage of women in leadership positions was even lower. To highlight
 the election of the seventh female AIA President, Kimberly Dowdell, AIA
 Graciela invited her as well as past and future women AIA Presidents —
 first time all women Nationals leaders participated together in a session—
 to a panel discussion to share their experience as AIA leaders and to
 advise the future AIA president.
- The WIA committee created a series of social media posts to highlight women in architecture. By 2024 more than 35 women had shared their architectural path and raised their visibility in the industry via these posts.
- Graciela helped other women architects to create their own AIA WIA Committees at their Chapters: Tampa Bay established in 2018, Brooklyn in 2019, Peconic in 2023, Queens in 2024.

AIA Long Island Emerging Professionals Committee:

- Under Graciela's leadership, the LIEPC created a mentorship program
 that provided an opportunity for students from the New York Institute of
 Technology and Farmingdale State College, as well as young professionals
 and established architects to meet, engage in discussion and gain insights
 from each other. Additionally, the LIEPC has collaborated with the NYIT
 chapter of AIAS to provide students with mock job interview events, a
 mentorship program, and critique sessions. To date, the program has
 had more than 350 participants. In 2024, it was renamed the "EnLighten
 Architecture Mentorship Program".
- Since its founding, the LIEPC has offered a popular ARE review course, a peer-led study group, with periodic guest speakers from the architectural community. In the past year, attendance has doubled with an average of 30 participants per session.
- As co-chair of the LIEPC, Graciela launched the EP Friendly Firms Award in 2019 to acknowledge firms that provide outstanding financial, educational and licensing benefits to emerging professionals.

- Under Graciela's leadership, the LIEPC has renewed, recharged, and spearheaded collaborations across the profession and industry. These collaborations have greatly broadened the chapter's exposure and renewed interest from students and emerging professionals.
- In 2018, Graciela led the creation of a guideline to help AIA Associates to achieve licensure. The guide was called "Architecture Registration Examination, Getting Started Booklet".
- In 2019 the AIA LI EP Committee was awarded the AIA NYS Component Award for its outstanding contribution to emerging professionals in the Long Island Chapter.

Challenge & Response

To tackle the pressing challenges in school planning and design, Graciela, as the AIA Long Island president in 2020, collaborated with Nassau Board of Cooperative Education Services (BOCES) on a comprehensive webinar series focused on case studies in public K-12 education. This initiative was developed in direct response to the complex issues faced by Long Island schools, particularly in the wake of the COVID-19 pandemic.

The pandemic significantly intensified design challenges for Long Island schools, reshaping how educational facilities are used and perceived. The webinar series raised public awareness and developed actionable strategies to improve and enhance educational facilities, ensuring they are adaptable to evolving needs. It also introduced architects, engineers, facilities directors, and architectural/engineering (A/E) design firms, to the intricacies of school design and planning, fostering a deeper understanding of the unique demands of this sector.

The design provided a Visitor/ Education Center, parking, access roads, infrastructure, hiking/nature trails, and other visitor facilities. The park is on an approximately 220-acre parcel and includes approximately one mile of undeveloped Long Island Sound shoreline. The park has made previously inaccessible resources now available to the surrounding community as well as to visitors from throughout the region. The facility is dedicated entirely to serving the public and promoting environmental and cultural awareness.

Role & Outcome

- Graciela was in charge of the design and development of construction documents of a Visitor.
- Education Center building and beach access boardwalk and trails. The Visitor/Education Center at the park entrance along Sound Avenue is a 3,600 sq ft energy efficient building containing exhibits, meeting space, public restroom facilities, and park management space.

As the lead on the 2022 publication of City Shapers: Stories of *Immigrant Designers*, Graciela faced the challenge of bringing together the stories of 24 immigrant professionals to represent a key pillar of the IAC's mission. Coordinating multiple authors, each with unique backgrounds and schedules, presented logistical hurdles. Graciela managed the entire process—from collecting and editing article submissions to organizing bios, headshots, and preparing the book layout—all while ensuring that the project met professional publishing standards. Additionally, she navigated the complexities of publishing on Amazon, including creating a Kindle version, and promoting the book at the AIA A'23 conference in San Francisco. Despite these challenges, the book became a best seller on Amazon and sold out at the conference
