Karen Lu has been an incredible mentor to me in the 10 years I have known her, and I am very honored to have been asked to sponsor her for consideration as a Fellow in the American Institute of Architects. Karen has made a uniquely valuable impact on our profession through her insights into how our practice has needed to evolve, and she is eminently qualified for Object Two: Practice Management. Karen's love of architecture is rooted in its complexity. She believes excellence in practice, like excellence in design, requires multiple measures of success and multiple points of influence. Many varied approaches are also required to make actionable progress. Karen leads with her values and actively cultivates equity in all aspects of her work. She believes that excellence in architectural practice is the foundation for design excellence in the built environment. Karen's influence is felt locally and nationally through her values-based leadership; her service to the AIA, academia, and the community; as well as her built work. Karen advances high standards for practice and shares them broadly.

#### LEADING WITH VALUES & ADVANCING STUDIO CULTURE

Over her 25-year career, Karen has contributed her leadership skills to three award-winning Minnesota practices—two of them national AIA Firm Award recipients. Her values of authenticity, collaboration, and equity have been influential, resulting in meaningful change at the places she has worked. Through her leadership in design, project management, and practice management, she has elevated studio cultures to new heights and shepherded impactful, award-winning projects. Under Karen's leadership at Snow Kreilich, the studio was one of the first in Minnesota to adopt intercultural development training for all studio members and obtain an International Living Future Institute Just Label, setting a new standard for inclusivity in the profession.

As an architect and a leader, Karen brings these values-based approaches to her volunteer work with the AIA and to the greater community. Karen has presented at schools of architecture and AIA chapters nationwide. In addition to speaking about design, she is often asked to discuss synergies in studio culture between design, sustainability, equity, and social impact goals—how to integrate the best ideas effectively and efficiently. The combination of exceptional accomplishment, outstanding analytical skills, and deep integrity makes Karen's perspective highly sought-after for regional and national presentations, juries, and search committees. Significantly, Karen was selected to represent local practitioners on searches for the heads of Minnesota's two NAAB-accredited architecture schools, the University of Minnesota (as well as their Design Justice Collective faculty) and Dunwoody College.

#### CULTIVATING FQUITY & FXPANDING SOCIAL IMPACT

Karen has impacted professional culture widely by emphasizing equity in practice and projects to promote a holistic understanding of design excellence. She advocates for equity at every opportunity: working with public and private clients, representing practice in academia, supporting emerging professionals, and envisioning the future of architectural practice. She believes that only from diversity, equity, and inclusion within firm culture, firm policies and practices, and firm members' engagement with community members can excellence in design and practice be achieved.

Karen's longstanding involvement in AIA Minnesota has centered on work to shape practice. Her firm leadership has informed and influenced AIA Minnesota's strategic priorities, and her AIA Minnesota leadership has informed and influenced her firm leadership. This centering of practice has had a flywheel effect, catalyzing change within her own firm and many others.

While serving as AIA Minnesota president in 2020, Karen led the local professional community through the pandemic of COVID-19 and was a leading voice during the worldwide reckoning with systemic racism ignited by the murder of Mr. George Floyd in Minneapolis. During this time, Karen advocated for equity and social justice with renewed urgency. Also, Karen led a years-long effort to strengthen awards programs to align with core values and the AIA. Under her leadership, the AIA Minnesota Honor Awards adopted the Framework for Design Excellence and Common App, and the number of Minnesota 2030 signatory firms increased by 26%. AIA Minnesota launched a new bi-monthly online publication focused on shaping a better built environment, and the Culture Change Initiative focused on changing mindsets in the profession. In addition, AIA Minnesota became the first AIA organization to hold a Just 2.0 Label. Karen shares this work broadly through her engagement at the national level through juries, the AIA Strategic Council, and various groups focused on equity in architecture with the purpose of empowering colleagues to elevate practice standards in the profession.

Karen believes excellence in architectural practice is the foundation for design excellence in the built environment.

Karen's focus on equity and design excellence applies to her roles as a studio leader, project manager, architect, and designer. Karen brings an equity lens to her built work as she continues to work on diverse project types, from non-profit emergency housing to large, complex public projects. Karen's strengths in synthesizing ideas, sharing knowledge, and connecting people raise the bar and advance the collective profession, all in service to architectural practice.



On the main level, a series of bi-fold doors open to a plaza facing the stadium, creating a multi-use space for events or popup retail. Rain gardens and planting areas support native and pollinator-friendly plants.

A processional stair travels up the south side of the building, encouraging active movement and providing panoramic views. Designed to complement the stadium and district, the garage will serve practical needs and delight visitors.

The existing building was an environmental bubble, sealed off from the exterior and compartmentalized into discrete, programmatic spaces. The renovation and addition extend periods of thermal comfort using low-energy, traditionally regional methods such as shading, fans, chilled-water surfaces, and a porous envelope. Layered programmatic spaces allow for collaboration, flexibility of use, and the ability to limit the area of more energyintensive spaces, including a lecture hall, bookstore, and food service.

# 2023 Strategic Council Design/AI Study Group Report

Strategic Council Artificial Intelligence Report 2023 | AIA Strategic Council

Role of Candidate: Chair, Design/ Artificial Intelligence (AI) Study Group

Karen led the first Strategic Council study group focused on Artificial Intelligence and its impact on architectural practice. She structured the report into three categories: immediate action, longer-term action, and future Strategic Council study.

The 2024 Design/Al Study Group adopted these recommendations for immediate study: working to form an Al Industry Consortium and a shared architecture Data Repository, developing alternative compensation models, and considering a recalibrated definition of "Health, Safety, and Welfare."

As a result of this work, Karen was invited to present at the AIA Minnesota conference and the Minnesota Construction Law Symposium on the ethics and risks of Artificial Intelligence in architectural practice.

# Young Architects Forum

Young Architects Forum Advisory Committee 2022-2023 | AIA Strategic Council

Role of Candidate: Strategic Council Liaison

As the Strategic Council Liaison on the Young Architects Forum (YAF) Advisory Committee, Karen advocated for inviting Young Architect Representatives to join Strategic Council Study Groups to provide a valuable and necessary perspective on the future of the profession.

Karen's advocacy resulted in a YAF representative joining the Design/ Al Study Group. The following year, the Strategic Council invited YAF members, National Associates Committee (NAC) members, and students to participate and provide their valuable, diverse perspectives on the state of architectural practice.

During Karen's tenure on the Strategic Council, she advised and mentored multiple Young Architects that were elected to AIA Board and Strategic Council leadership positions.



EVP Evaluation Process and Assessment 2021 | AIA Minnesota

Role of Candidate: AIA Minnesota Past President & Author

During a period of trememdous social and financial instability, Karen updated and formalized the AIA Minnesota Executive Vice President (EVP) evaluation process to support and strengthen the relationship between multiple boards and the EVP.

Karen conducted research to implement best practices for nonprofit board governance. She established an evaluation timeline, drafted assessment instruments tailored to five boards, incorporated staff input, and created a framework for setting annual organization and leadership performance goals.

Karen's proposal for a bylaws amendment to change the committee's name to reflect ongoing support of the EVP, add the Treasurer to strengthen the connection between performance and compensation, and appoint the Immediate Past President as chair was approved.

Role of Candidate: AIA Minnesota President & Resource Team Member

Karen was a member of the Culture Change Resource Team, which provided input on the current state of the culture of the profession in order to define the desired culture and accelerate progress toward achieving that culture.

The resulting Culture Change Initiative highlighted mindsets accelerating an Authentic, Equitable, and Collaborative culture in architectural practice. She has shared the presentation broadly with firms across the country, schools of architecture, other AIA chapters, and the AIA Strategic Council.

Since 2021, Karen has belonged to the Community of Practice for Culture Change, a group of professionals from around the country who apply the learnings, share perspectives, and continue to refine their approaches.

In 2019, Karen served on the Architecture Minnesota Magazine Branding Task Force to develop a financially viable replacement for AIA Minnesota's bi-monthly print magazine. The work led directly to ENTER, an online monthly and annual print publication aimed at a wide public audience, with its five content pillars: climate, equity, experience, economy, and innovation.

Following the redevelopment, Karen has continuted to work with ENTER as an Advisory Committee Member, which has give Karen opportunities to connect with a wide audience aligned with the mission of the publication. The print annual also highlights AIA Minnesota Honor Award recipients and includes a directory of architecture firms and consultants.

As Co-chair, Karen began a continuous and comprehensive process of evaluating and improving AIA Minnesota awards programs with respect to sustainability and equity.

Karen championed incorporating the AIA Framework for Design Excellence, which addresses multiple measures of design success, into the Honor Awards. The program now requires submission of the Common App and adds a new "Commendation" recognition for projects that excel in a particular measure of the Framework.

She also engaged the committee in a thorough review of the Young Architects Award process, which led to providing support for interested candidates; changes in evaluation criteria, jury composition, and submission requirements; guidance to jury members; and greater definition of staff roles, which has informed AIA Minnesota's other honors and awards.

Karen has served on the AIA Minnesota Leadership Forum Advisory Committee since she completed the program's inaugural session in 2010.

As Co-chair, Karen increased the participation of women and people of color in the leadership program: people of color by 71%, women in the facilitator role by 32%, and women in the program by 23%.

The advisory committee continues to fine-tune and evolve the curriculum based on feedback to address the changing needs of the profession. Content in recent years has focused on advocacy and intercultural development training. Karen's advocacy for equity resulted in the program eliminating licensure as a requirement for application, increasing cohort diversity.

#### CHALL FNGF

From post-pandemic operations to the myriad impacts of built work, contemporary architectural practice faces a multitude of challenges that require addressing simultaneously. Just as contributions to the built environment must address ever-changing physical, social, political, economic, environmental, and cultural contexts, so does the architectural profession.

#### ROLE OF ADVANCING STUDIO CULTURE THROUGH PRACTICE

Karen's leadership at Snow Kreilich Architects has **elevated professional practice by advancing studio culture**. Based on values of authenticity, collaboration, equity, and integrity, Karen has developed policies and procedures in pursuit of bettering the profession which have resulted in systemic change. Karen has instituted **annual equity training for all studio members and participation in the AIA Minnesota Foundations of Intercultural Development for new hires**. Karen also advocates for studio members to participate in the AIA Minnesota Leadership Forum and AIA Minnesota National Intercultural Leadership Program to develop their personal and professional leadership skills with a focus on values, intercultural development, communication, advocacy, engagement, and future AIA leadership.

To advance the studio's accountability in equity and social justice, Karen led Snow Kreilich's efforts to obtain an International Living Future Insitute Just Label, one of the first architecture firms in Minnesota to do so. Karen managed this initiative across the studio which included raising the lowest salaries for recent graduates, increasing parental leave, updating personnel handbook policies, and implementing an annual Snow Kreilich Equity & Inclusion Survey. Karen's interest and experience led to board approval and support of AIA Minnesota as the first AIA-related organization to hold a Just 2.0 Label. The Just Label was one of sixteen equity tools and assessments that Karen recently shared with the AIA Strategic Council and Board.

#### 3.1 LEADING WITH VALUES & ADVANCING STUDIO CULTURE

Under Karen's leadership, Snow Kreilich was recognized with multiple AIA Emerging Professional Friendly Firm Awards. As a result, Snow Kreilich changed its policy to include reimbursement for all ARE fees, including failed exams, and unlike many firms, Snow Kreilich also covers AIA and NOMA membership fees for all studio members.

#### ROLE OF ADVANCING STUDIO CULTURE THROUGH SERVICE

As 2020 AIA Minnesota President and an active, long-term member on multiple committees, Karen's leadership within AIA Minnesota has advanced practice by promoting and developing initiatives based on values of authenticity, collaboration, equity, and integrity in pursuit of bettering the profession.




The AIA Minnesota Leadership Forum develops and fosters leadership skills of mid-career members of AIA Minnesota and MSP NOMA. The curriculum provides insight and tools for growth in leadership styles, values, self-awareness, intercultural leadership, communication, motivation, and engagement in practice.



The Culture Change Initiative (CCI) is an ongoing effort to examine the current state of the culture of the profession, to define the desired culture, and to accelerate progress in achieving that desired culture in practice.

Immediately upon licensure, Karen was recommended for the inaugural Leadership Forum program. Ever since, as a member of the Leadership Forum Advisory Committee, Karen has been working tirelessly to continuously fine-tune and evolve the curriculum based on participant feedback and to address changing needs of practice. She introduced the Intercultural Development Inventory Assessment as a self-awareness tool and advocated for removing licensure as a requirement for application, both changes addressing the need for a more equitable profession. As co-chair, Karen increased the participation of women and people of color in the leadership program through personal outreach: people of color by 71%, women in the facilitator role by 32%, and women by 23%. A firm believer in the program's strengths, Karen actively recruits participants from both Snow Kreilich and the local professional community.

Karen was a member of the initial Culture Change Resources Team, providing input on the current state of the profession over the course of two years, leveraging insights from the AIA Guides of Equitable Practice to change mindsets and accelerate an authentic, equitable, and collaborative culture in practice. Karen presented the Culture Change Initiative to Snow Kreilich in 2020. In 2021, Karen joined the Community of Practice for Culture Change, a group of people from around the country who apply these learnings, share perspectives and impacts, and continue to refine their approaches. In 2022, Karen facilitated a Culture Change Initiative presentation to the Strategic Council and Board. She continues to share this work broadly with firms, schools, and AIA chapters nationwide.



The Culture Change Initiative has reached 30+ architecture firms, 20+ universities, and more than a dozen architecture associations, totaling over 15,000 people.

#### OUTCOME

Karen's centering of practice has had a flywheel effect, catalyzing change within her own firm and many others within the professional community. A feedback loop is evident in her long-term committment to AIA service, improving programs through volunteer service and recommending Snow Kreilich studio members and others participate in these programs, a relationship that both elevates practice at Snow Kreilich and throughout the Minnesota architectural practice community.

Karen is often asked to discuss synergies in studio culture with the multiple project priorities of design, sustainability, and equity. Her values of authenticity, collaboration, equity, and integrity make Karen's a highly sought-after voice in faculty selection committees, and AIA honors and awards juries. She shares her efforts to elevate practice broadly through professional practice panels and presentations nationwide. Significantly, Karen was selected to represent practitioners on searches for the heads of Minnesota's two NAAB-accredited architecture school.

Karen promotes a professional culture that cultivates equity and social impact in practice and the built environment. She advocates for equity at every opportunity: working with clients, representing practice in academia, supporting emerging professionals, and envisioning the future of architectural practice. While serving as AIA Minnesota president in 2020, Karen led the local professional community through the pandemic of COVID-19 and was a leading voice during the worldwide reckoning with systemic racism ignited by the murder of Mr. George Floyd in Minneapolis.

#### CHALLENGE

Architectural practice has historically and systemically disadvantaged women and people of color, both in the profession and the communities we serve. What can architectural practice (Snow Kreilich Architects) and professional service (AIA Minnesota) do to increase equity and expand social impact in the profession and the built environment?

#### ROLE OF EXPANDING SOCIAL IMPACT THROUGH PRACTICE

Karen has advocated for equity at Snow Kreilich in pursuit of advancing social impact within the profession and built environment. In 2018, when Snow Kreilich received the AIA Architecture Firm Award, it was observed that over 50% of the staff were women and people of color. Currently, that number is almost 65% due to Karen's dedication. Diversity matters, but it is not enough. In 2020, Karen led the drive to increase the studio's self-awareness and capacity to bridge across cultural differences. After the murder of Mr. George Floyd just a few miles south of Snow Kreilich's offices, Karen facilitated the collaborative development of equity and inclusion goals by studio members, for studio members, the studio as a whole, and the design process, internally as well as externally.

Karen guides Snow Kreilich's support of local BIPOC students and professionals through mentorship, internships, and the Minnesota Architectural Foundation's Clarence Wigington Architectural Scholarship. Due to Karen's leadership and engagement with MSP NOMA, Snow Kreilich — a firm with only 32 studio members — has the most MSP NOMA members of any firm in Minnesota. In 2021, Karen led the successful application for a NOMA Foundation Fellowship (now the NOMA Future Faces Fellowship) - one of the first in Minnesota, resulting in a mutually beneficial relationship.

#### ROLE OF EXPANDING SOCIAL IMPACT THROUGH SERVICE

Karen has prioritized equity in professional, academic, and community service. She has worked tirelessly to increase equity by mentoring students of color, supporting additional pathways to the profession, recruiting leadership from underrepresented demographics in the profession, implementing the AIA Framework for Design Excellence in awards requirements, and sharing stories of equitable projects and thought leadership of BIPOC architects and designers with the greater professional community and the public at large.



The AIA Minnesota Committee on Design is charged with overseeing the creation and implementation of all AIA Minnesota award programs. They provide guidelines for each award and either secure jurors or act as the selection committee for AIA Minnesota awards.

ENTER, a print annual and digital monthly from the creators of Architecture MN magazine, explores the people, places, and ideas shaping a better built environment for Minnesota.

Karen championed incorporating the AIA Framework for **Design Excellence**, which addresses multiple measures of design success that encompass equity and sustainability. into the AIA Minnesota Honor Awards. The program now requires submission of the **Common App** and adds a new "Commendation" recognition for projects that excel in a particular measure of the Framework. Karen also engaged in a thorough review of the Young Architects Award process, which led to support for interested candidates. changes in evaluation criteria, jury composition, submission requirements, guidance to the jury, and definition of staff roles, which inspired and informed a comprehensive review of AIA Minnesota's other honors and awards. The new AIA Minnesota Next Gen Award, recognizing recent graduates of a NAAB-accredited architecture program, was developed under Karen's leadership.

In 2019, Karen served on the Architecture Minnesota Magazine Branding Task Force to develop a financially viable replacement for AIA Minnesota's monthly print magazine. The visioning work led directly to ENTER, an online monthly and annual print publication aimed at a wide public audience, with its five content pillars: climate, equity, experience, economy, and innovation.

ENTER focuses on the people, places, and ideas shaping a better built environment for Minnesota. A print annual highlights AIA Minnesota Honor Award and Commendation recipients and includes a directory of Minnesota architecture firms and consultants. Karen has continued her work on ENTER as an Advisory Committee Member and content contributor.

#### OUTCOME

The efforts to achieve an equitable profession and built environment are ongoing, and the context surrounding equity, diversity, and inclusion efforts has also faced recent challenges. It will take many individuals, firms, and organizations taking action to make an impact. Karen's leadership in cultivating equity through practice and professional service has emphasized multiple approaches, internally and externally, toward making progress.

At Snow Kreilich Architects, Karen has expanded the social impact of architecture by building and fostering relationships with BIPOC architecture students, design professionals, firm leaders, firm owners, and consultants. She has implemented equitable studio practices for hiring, pay equity, and mentorship. Karen also organized Snow Kreilich's support of PTO for staff members to volunteer their time and matching donations for studio members contributing to organizations that work to eliminate racial inequity.

As 2020 AIA Minnesota President, Karen led a response to the unrest following the deaths of Mr. George Floyd and others in our community, in which AIA Minnesota collaborated with MSP NOMA on a program to match owners of damaged properties with BIPOC-led design teams. She also **centered the voices of Minnesota's Black and POCI architecture community in local and national media**.

More recently, as an AIA Strategic Council representative, Karen has contributed to Equity study groups that broadly share AIA Minnesota's nationally recognized work and focus on research to study "How do AIA members and firms demonstrate an ongoing commitment to Diversity & Equity?" She has led the proposal of recommendations to the AIA Board that include updating the AIA Code of Ethics and Professional Conduct to add architects advising their clients of their obligation to "affected communities," and developing a firm self-assessment tool that addresses equity, as recommended by the 2017 AIA EDI Commission.

An American School Immerses Itself in All Things Chinese

MINNEAPOLIS — On weekday mornings, a stream of orange buses and private can from 75 Minnesoth postal codes wrap around Yinghua Academy, the first publicly funded Chinese-immersion charter school in the United States, in the middle-class neighborhood of Northeast Minneapolis Most pupils, from kindergarten to eighth grade, dash to bright-colored classrooms for the 8:45 a.m. bell, eager to begin "morning meeting," a freewheeling conversation in colloquial Mandarie.

Karen's leadership at Yinghua Academy, a local Chinese immersion K-8 school, is a model for the broad value of skills developed in architectural practice to make a positive impact. Karen shares this experience with architecture students in professional practice as an example of using architecture to advance the public good and shape future generations of diverse leaders.

#### YINGHUA ACADEMY

Minneapolis, Minnesota

Yinghua Academy is a national leader in Mandarin Chinese immersion education. The bilingual, tuition-free, public K-8 charter school offers an international perspective. Established in 2006, it is the first Chinese immersion charter public school in the U.S.

#### CHALLENGE

In 2008, Yinghua had 245 K-5 students. Due to the high demand for its program, the addition of grades 6-8, and the enrollment projected to double in five years, Yinghua needed a strategic plan for future growth that considered enrollment, facilities, and finances.

#### ROLE

As a community member, Karen joined the Facilities Committee and advised on the purchase of a new school building and the move of operations from St. Paul to Minneapolis. In 2011, Karen joined the school board and was appointed Secretary. Over her ten years in leadership at Yinghua Academy, Karen served in multiple capacities, including being elected Board Chair.

Karen worked closely with the CEO/Executive Director, leading the development of enrollment projections, board committees, annual goals, and Annual Reports. Her skills as a practicing architect were instrumental in strategizing and implementing multiple synergistic goals

encompassing academics, finance, governance, and personnel, all significantly contributing to Yinghua's growth and community integration.

#### OUTCOME

Yinghua's school board developed and implemented comprehensive short-term and long-term facility plans that required the approval of the charter school authorizer and state bonding. As Secretary and Chair, Karen coled applications for a temporary Kinder Campus, bond financing, and facilities expansion. As a result, in June 2013, Yinghua received \$14.1 million for a 38,000-square-foot addition and a 46,500-square-foot renovation construction project. Today, Yinghua Academy is a thriving majority-minority school with over 800 students and a neighborhood institution in Northeast Minneapolis.

Karen now serves as Board Secretary of Yinghua's affiliated building corporation, responsible for maintaining bond compliance and overseeing capital expenditures.



#### Role of Candidate

St. Paul Academy's Upper School is known for its innovative and dynamic curriculum designed around the Harkness method, a student-centered, discussion-based teaching method developed in the 1930s.

#### **CHALLENGE**

St. Paul Academy's aspiration for an inspiring and supportive environment required rethinking the Upper School campus and unifying an original 1916 schoolhouse, a 1970s cast-in-place addition, and a new math and science wing to provide a cohesive academic experience.

#### ROLE

Karen led the programming, planning, and design process of the Addition and Renovation's interiors with Senior Project Manager Jim Moore. She worked closely with school leadership and the design team to develop a unique approach to classrooms and their support spaces to inspire and support students' development as individuals and within a larger community.

#### OUTCOME

The Upper School addition and renovation is designed to foster a new era of learning. The new state-of-the-art math and science facilities and remodeled humanities wing are equipped with classrooms clustered with open, flexible working spaces and private study spaces, promoting collaboration and self-direction. Each cluster also includes faculty offices and specialty support spaces. These clusters are woven together by circulation that strategically widens to host occasional

larger group meetings and provide community gathering areas. Floor-to-ceiling windows reinforce the courtyard experience from the interiors, allowing for views of green space and students across the campus lawn. Similarly-detailed glazing is used in the interior to create strategic programmatic connections. The various spaces share a common theme of natural light, color, and consistent finishes to provide continuity throughout the school's building's three different eras and to serve and inspire students in their studies





#### Role of Candidate

Salt City Market is a Syracuse market and food hall that builds community through food - shopping, eating, and cooking - and generational wealth for underrepresented chef-entrepreneurs doing what they love.

#### **CHALLENGE**

The site is located at the convergence of several neighborhoods and was most recently a vacant parking lot after fires destroyed previous buildings. The Allyn Foundation envisioned a new landmark on this important site that would celebrate the diversity of Syracuse by bringing different cultures and people together through food.

#### ROI F

Karen led the design of the mixed-use facility's massing and envelope with Design Principal Julie Snow, FAIA. She worked with the client and design team to develop a building that celebrates the significant site and showcases underrepresented populations and their cuisines in downtown Syracuse. Focus groups and community gatherings ensured that everyone in Syracuse would feel connected and invested in the project.

#### OUTCOME

The architecture maximizes the market's presence by holding the street edges to the southeast and west while cradling an outdoor space for year-round outdoor activities, dining, and public parking. The mixed-use development combines a food hall and public market on the first floor, non-profit office spaces on the second

floor, and 26 apartments on the third and fourth floors. The building follows a rotational geometry that allows independent floor plate sizes and view corridors specific to each use. The building envelope is designed with restraint, allowing the vitality and energy of the first floor to come forward.

Salt City Market has activated downtown Syracuse, providing an iconic place where underrepresented entrepreneurs can learn how to start and maintain a business. The result is a development where the entire community feels a sense of belonging and ownership.



Major League Soccer's first club to be majority-owned by women began with a vision that extended beyond sports and sought to make CITYPARK a dynamic stadium district and civic destination that would bring fresh energy and pride to the city.

#### CHALLENGE

The design team of Snow Kreilich Architects and HOK worked closely with the ownership team to ensure that, along with the other new additions in Downtown West, the club's stadium district would **play a pivotal role in St. Louis' revitalization** and serve as a connection point between The Gateway Arch and Forest Park. A key client objective was the creation of enhanced and distinct fan experiences 365 days a year.

#### ROI F

Karen led the complex design process during Schematic Design and Design Development with Julie Snow, FAIA, working closely with architect partners HOK and St. Louis CITY SC leadership. Karen's project responsibilities focused on interior and exterior public spaces to be used by the community year-round. CITYPARK features a best-in-class fan experience that is modern, inclusive, and distinct, offering access and providing unique fan engagement strategies. CITYPARK is more than just a stadium. It's where architecture, green space, and gathering places come together to inspire CITY fans and the city of St. Louis.



#### 1950 OLIVE PARKING GARAGE

St. Louis, Missouri

Design & Architect of Record: Snow Kreilich Architects

The 1950 Olive Parking Garage captures the adjacent soccer stadium's civic energy while supporting every day and match-day community connections.

#### CHALLENGE

On a fundamental level, garage design should allow cars to be parked efficiently, quickly, and unobtrusively. The higher aspiration for 1950 Olive was to be more than just a parking garage; it wanted to be a sustainable civic asset.

#### ROLE

Karen led the design of the all-electric facility with Design Principal Julie Snow, FAIA. She worked closely with the client to ensure the parking garage functioned as "more than a parking garage" by acting as an extension of the Stadium District and supporting other modes of transportation.

#### OUTCOME

The design animates a quiet, stainless steel mesh volume with bold elements in the STL CITY's team colors. On the main level, a series of bi-fold doors open to a plaza facing the stadium, creating a multi-use space for community events and pop-up retail. A processional stair travels up the south side of the building, encouraging active movement, and a balcony provides panoramic views. The all-electric garage is structured for future installation of photovoltaic panels.

The parking garage supports visitors to the district on game day and citizens working there throughout the year. The garage provides vehicular and bike parking and a

bike repair station for fans coming to games and local businesses. The garage was designed to complement the stadium and district, serve practical needs, support the Great Rivers Greenway network of bicycle routes, and delight visitors and passersby. The parking garage is an infrastructural element transformed into a public space.

#### Role of Candidate

Design Director & Design Project Manager

Opened in 1957, Steinberg Rink is the largest outdoor ice-skating rink in the Midwest and one of the first racially integrated public facilities in the city. A popular winter destination for all St. Louisans, the project will transform this Forest Park complex into an all-season destination that is welcoming to all.

#### CHALLENGE

The Steinberg Pavilion and Rink, a beloved public institution since 1957, is set for a transformative renovation and expansion. The program resulted from an extensive community process aimed at extending the building's use year-round and attracting a larger, more diverse public.

#### ROI F

Karen managed the complex design process, working closely with Forest Park Forever, multiple public stakeholders, and a large design team to develop the project vision and design. She also participated in community stakeholder interviews and presented at owner and public advisory committee meetings and virtual and in-person open houses to gather community feedback.

#### OUTCOME

Equity was at the core of every decision to accommodate a diverse public, from researching the facility's cultural history at the height of its popularity in the 1960s to economic market analysis in support of subsidizing ticket sales to engaging with the community and designing multi-functional public spaces. The current design reflects

the community's needs and aspirations, resulting from the direct input of more than 4,200 people.

With the support of Karen's leadership and focus on equity, the Steinberg Pavilion was reimagined as an inclusive, equitable, and environmentally sustainable public amenity. Snow Kreilich emphasized the importance of respecting and not overwhelming the historic structure or its verdant park setting. The building was extended below grade to house 60% of the addition, with two light pavilions activating the roof terrace for public use. The project implements flexibility of use, broader accessibility considerations, a complementary palette of contemporary materials, and innovative sustainability measures for the region, including triple-pane glazing and a geothermal mechanical system. This commitment to equity and sustainability ensures a long-lived facility that will serve the diverse community of St. Louis and beyond.



The Lakewood Welcome Center is a new front door to the storied cemetery. It combines an enhanced and inclusive visitor experience with an efficient and effective workspace for a growing staff to support innovative programs that expand the cemetery's role further into the community and broaden end-of-life commemoration.

#### CHALLENGE

Lakewood's aspiration to create a more **relevant**, accessible, and inviting visitor experience sparked a comprehensive reassessment of the existing 1920s-era Administration Building and the need to balance long-standing tradition with stewardship and innovation.
